If you or your dependents have medical expenses or a disability, please use the following checklist to assist you in gathering information for the purposes of preparing your personal T1 tax return.

	Medical expense receipts - the following elements are required on each receipt:
	Services received or products purchased
	Date of payment
	Name of the patient for whom the payment was made
	 Name of the medical practitioner who prescribed the purchase or gave the service.
	Doctor's prescription/letter for eligible medical expense items which do not require a prescription for purchase (e.g. bathroom aids, walking aids, orthotics, gluten-free products, etc.).
	Statement from your pharmacy listing details of prescriptions you purchased, or individual receipts. (Note: Medications available over-the-counter are generally not eligible medical expenses, even if prescribed and filled by a pharmacist)
	Private/group medical plan premiums (excluding MSP premiums and not included on T4(A) slip) – Statements/Letter required.
	 Premiums for travel medical insurance policies (medical insurance portion only).
	Reasonable meals, accommodations, and transportation expenses if you had to travel at least 40 km (one way) from your home for medical services.
	 For meals and vehicle expenses, instead of keeping receipts, a flat rate calculation may be used based on the number of kilometres traveled.
	 Expenses for a travel companion may also be claimed if you have a letter from the doctor stating you cannot travel alone.
	Disability supports expenses (speech, sight, hearing, learning aids for impaired individuals) incurred for the purpose of employment or education.
	Fees paid to an attendant for medical care.
	 Fees paid to a spouse, or child under 18 years do not qualify
	 If an individual is hired directly rather than through a company, you may have payroll and T4 filing requirements.
	Disability Tax Credit and/or letter from medical practitioner required.
	Fees paid to a nursing home (full-time care) or the attendant care portion of fees paid to an assisted living care home.
	Detailed receipts required
	 Disability Tax Credit and/or letter from medical practitioner required.
	Eligible medical expenses paid for family members (including in-laws) who depended on you for support.

Home Accessibility Tax Credit

Home Accessibility Tax Credit (<u>additional</u> credit also available for BC residents) – receipts for renovations to your home to improve accessibility for qualifying individuals.

Disability Tax Credit

- ☐ Are you disabled or are any of your dependents disabled? You may qualify for the Disability Tax Credit.
 - Form T2201 Disability Tax Credit Certificate must be completed by a medical practitioner

Medical Expenses and Caregiver Credits for Dependents

You may also be eligible to claim other tax credits for family members with a physical or mental impairment and dependent on you for financial support.

- □ Details including your dependent's name, date of birth, relationship to you, net income, description of physical or mental impairment, and names of others providing support to the same individual.
- ☐ Receipts for medical expenses you paid for your dependent
- □ Caregiver Credits
 - Approved T2201 Disability Tax Credit Certificate, or,
 - A signed statement from a medical practitioner indicating when the impairment began and what the duration of the impairment is expected to be
 - For children under age 18, the statement should also indicate that because of the impairment the child will be dependent on others for a long and continuous period and requires more assistance for personal needs and care when compared to children of the same age.

Registered Disability Savings Plan (RDSP)

Any person eligible for the disability tax credit, or their parent or legal representative, may be eligible to establish an RDSP which also receives government grants. For further information, contact your financial institution or investment advisor.

Canada Dental Benefit

A tax-free payment to cover dental expenses for seniors and children under the age of 12 without dental coverage. Limited to families with an adjusted family net income under \$90,000. Applications for the benefit can be made online using your <u>CRA My Account</u> or by phone at 1-800-715-8836.
